TUITION

All students in Pre-K 3 & 4 must pay this tuition regardless of how many children are attending St. Rocco School. If a family consists of three or more children, the “additional child” discount will be applied to the eldest child.

***Aftercare Policy Change for PRE~K3 & PRE~K4 ONLY**

Beginning January 2, 2018 PRE~K3 & PRE~K4 Before/Aftercare is included in TUITION.

FEES Due at the time of Application for Admission

Family Application Fee* \$100

***Please note:** You may be eligible for exemption if your family has been registered at St. Rocco School for three consecutive years prior to the 2018-2019 school year and your child is registered by January 15, 2018.

Academic Fee Per Child (PK-8) \$175

(Including, but not limited to: consumable workbooks, school, art & technology supplies and curricular resources)

These fees are non-refundable. However, if your child is not accepted, these fees will be refunded.

FUNDRAISING

- Each family is expected to bring in a profit of \$500 in fundraising or pay this amount to the school by May 11, 2019. This fee is added to your tuition plan. All monies raised by you through specified school-sponsored fundraisers will be applied to your account as a onetime credit after January 2019.

Please note: If tuition is being paid in full, then fundraising fee must be paid in full at the same time.

TUITION POLICY/CONTRACT **

A. Tuition Payments:

- Tuition is payable over an 11 month period through ***FACTS*** or if being paid in full must be paid by July 15, 2018.

Conditions:

- Families who choose the eleven month plan and miss a monthly payment due to insufficient funds will be automatically charged a fee by ***FACTS*** and may be also charged by their banks.
- Tuition is considered “Past Due” if not paid by the predetermined choice of the 5th or 20th of each month. Saint Rocco School will grant a five day grace period before a late fee of \$25.00 will be charged. All difficulties regarding tuition payments must be referred to the Parish Bookkeeper, AnnMarie Cardente at the Parish Office ~ 401.942.5203
- A \$250.00 fee will be charged by St. Rocco School if tuition is not paid in full by May 11, 2019.
- No student will be allowed to begin classes unless tuition payments are up-to-date.
- If for any reason tuition payments fall 15 days in arrears, students will not be permitted to attend school until the account is brought up-to-date.
- Students who are absent from school for more than 10 school days due to overdue tuition payments will be asked to withdraw from St. Rocco School and official transfer papers will be processed.
- 8th graders will not be permitted to take part in graduation ceremonies and activities unless all tuition and fee obligations have been met.
- The account will be forwarded to a collection agency and/or legal counsel.

B. Tuition Paid in Full:

- If you chose to pay your child’s tuition in full, payment **MUST** be paid by July 15, 2018.

C. Tuition Refunds:

- Students who withdraw prior to the beginning of school will not have tuition refunded unless they have paid in full. In this case 9/11 of the tuition will be refunded.
- Students who withdraw prior to October 2, 2018 will be charged 3/11 of the annual tuition and the remainder will be returned.
- Students who withdraw after October 2, 2018 will be charged the full tuition.
- Refunds will not be considered until the parent/guardian has signed an official notice of transfer/withdrawal.
- Students who leave school as a result of a disciplinary action will not be granted a tuition refund.

D. Returned Checks:

- A \$25.00 charge will be added to any bill from St. Rocco School for all checks that are returned by the bank due to insufficient funds.
- St. Rocco School will not accept personal checks that have not been certified by the bank two weeks prior to exam time or at the end of the academic year.
- St. Rocco School reserves the right not to accept personal checks under certain circumstances.
